For Students Seeking Admission to the Spring 2025 Program

The Limited Entry Office will be responsible for managing the application process. The selection of students is done by an admissions committee. Oualified applicants must:

- Complete a Health Programs Orientation, meet with a Health Programs Advisor within 2 years application deadline, and complete a Limited Entry Workshop within 2 years of application deadline (https://www.csn.edu/health-programs-advising)
- Satisfy English language proficiency requirement (https://www.csn.edu/nursing-associate-of-applied-science).
- Have a high school transcript (showing date of graduation), GED transcript, HiSet transcript, or transcript for Associate's degree (or higher).

 Note: International (non-US) transcripts must be evaluated through a NACES member organization (https://www.naces.org/members)
- Have a minimum cumulative GPA of 2.50 for all program prerequisites.
- Have a minimum cut-off score of 80% in Reading, 80% in Math, 75% in English, and 80% in Science on the ATI Test of Essential Academic Skills
 (TEAS) exam. Test scores are valid for 5 years and attempts are unlimited. EXCEPTION: Students may apply with minimum test scores of 80% in
 Reading, 60% in Math, 60% in English, and 60% in Science; however, zero points will be awarded for the TEAS and selection into the program
 will only be considered if space is available, after all qualified applicants have been selected.

Applicants will be ranked and selected using a point system through which points will be awarded. Please see attached Selection Criteria sheet (also available at: https://www.csn.edu/nursing-associate-of-applied-science).

PROGRAM PREREQUISITE COURSES: These are courses that must be completed before a student is considered eligible for entry into the Program. FOR SELECTION PURPOSES, PREREQUISITE COURSES FOR LIMITED ENTRY PROGRAMS MAY BE ATTEMPTED <u>THREE TIMES.</u> ALL ATTEMPTS INCLUDE WITHDRAWALS, AUDITS AND GRADES. THE HIGHEST GRADE WILL BE USED FOR THE GPA CALCULATION.
