This form must be completed on-campus in the presence of an approved representative of College of Southern Nevada, or in the presence of a notary public. To complete this form, choose one of the following options:

OPTION 1: APPEAR IN PERSON AT COLLEGE OF SOUTHERN NEVADA

The student must appear in person at College of Southern Nevada to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID. Note that an ID issued by a state university or college is not sufficient for this purpose. Nor is a military ID since 18 U.S. Code § 701 prohibits it from being photocopied.

In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.

OPTION 2: APPEAR IN PERSON AT A NOTARY PUBLIC
